## PASTORAL SUPERVISION AND REFLECTIVE PRACTICE

Michael Paterson, co-author with Jane Leach of *'Pastoral Supervision: a handbook'* (SCM 2010) and one of the founders of APSE (The Association of Pastoral Supervisors and Educators) is leading a course entitled 'Skills in Pastoral Supervision and Reflective Practice' in the Gillis Centre in Edinburgh ([www.gilliscentre.org.uk](http://www.gilliscentre.org.uk)) from 12<sup>th</sup> to 14<sup>th</sup> September 2011. The course - 3 days/2 overnights - will involve teaching input, skills practice, group reflection/supervision, peer reflection/supervision.



### A deeper reflection

This practical course is designed for people of faith who want to reflect more deeply on their own work and ministry and enhance competence and confidence in supervising others or in facilitating reflective practice. It aims for each participant to experience group supervision and reflection which is rooted in prayer and scripture; practise key skills in supervising and/or reflecting with individuals and groups; develop their own style of supervising and/or facilitating

### Underpinning

The course content will include: identifying the vision underpinning our work and ministry; listening to God through prayer and Scripture, head and heart; creative approaches to eliciting the stories people bring from their work; techniques for encouraging reflective practice; bringing 'theological reflection' alive; unconscious processes at work in supervision and in ministry; common issues raised in supervision and reflection (change, conflict, interpersonal tensions etc).

### Possible applications

Commenting on the purpose of the course, Michael says: 'The course is ideally suited to healthcare chaplains and others associated with our work. Participants will gain skills in facilitating verbatim or reflective practice groups, and well as gaining confidence in energising team meetings through a wider repertoire of interventions. In addition, it is hoped that the course will lead to an improvement in ability to supervise trainees or students on placement and in the setting up of peer supervision or reflective practice groups.'

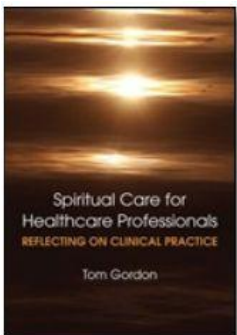

## FOR HEALTHCARE PROFESSIONALS

Three members of the UKBHC Board, Tom Gordon, Ewan Kelly and David Mitchell, have collaborated on a new text-book resource, *Spiritual Care for Healthcare Professionals: reflecting on clinical practice*. (ISBN 9781846194559) The book is due for publication by Radcliffe Publishers in August and will be officially launched in October/November in Glasgow University.

Aimed at all healthcare professionals, it can be used by individual practitioners for continuing professional development as well as by academic staff developing educational programmes.

## THE SCOTTISH SCENE

Plans are in place, under-pinned by the Scottish Government, for a major multi-disciplinary international conference on spiritual care in the Beardmore Conference Centre in Clydebank on 13<sup>th</sup> and 14<sup>th</sup> March 2012. The conference, *Meeting Spiritual Needs: Enhancing Wellbeing, Improving Outcome*, will have as keynote speakers: George Fitchett (Longstanding Chaplaincy Researcher USA), Harvey Chochinov (Mindfulness in Palliative Care, Canada), Scott Murray (Spiritual Distress and Disease Trajectories, Scotland), Harriet Mowatt (Patient Outcome & Cost Effectiveness - Community Chaplaincy Listening, Scotland). Other international speakers from a variety of disciplines will be invited to lead workshops.

### Workshops and poster presentations

There will be an opportunity soon to submit a workshop or poster abstract so that chaplains and other healthcare professionals may present their research and best practice to an international gathering. Ewan Kelly, programme director for chaplaincy in Scotland, suggests, 'This conference will enhance the standing of spiritual care in healthcare provision. ## VOLUNTEERS

Mark Stobert, President of CHCC, has been working on paper concerning chaplaincy visitors and volunteers. The paramount concerns are competence and safety for patients and carers, and that the standard of delivery of service is held appropriately within the chaplaincy province. The issues raised in this helpful paper will be taken forward, particularly in respect of the need for clarity of definitions and roles, and will be processed appropriately forthcoming months.

## ADVISERS

Further work is being done on the establishment of a 'Reference Panel' in the area of advisers for healthcare chaplaincy appointments. This process has the blessing of the Department of Health, and the funding will commence on 1<sup>st</sup> October 2011. Work will continue through the co-ordination of the panel and the advisers and the setting up of a process that is both robust and accountable.

### The Reference Panel

The reference panel will report as its work unfolds, and, through its lead officer for its Professional Advisers strand – the capable hands of Malcolm Masterman - the UKBHC will continue to be fully focussed on and engaged with this issue.

## THE GOVERNANCE OF THE BOARD

The Board has been giving thought to firming-up its structures as it moves from an 'interim' to a 'final' form. This is informed by our discussions with the CHRE, and the constitution of the Board should be appropriate to the proposed regulatory processes. It is clear that the Board is 'on a journey' and that the future shape of the Board may have to be further developed. The Board considers that its structure and its work should be appropriate, realistic and transparent.

### Revised constitution

With this in mind, the Board has appointed a sub-group to review its constitution so that its structures might appropriately reflect its progress in recent times, as well as current circumstances and future aspirations. It is hoped that a revised constitution might be presented in its entirety at the AGM.

The UKBHC appreciates its on-going contact with the Multi-Faith Group on Healthcare Chaplaincy (MFGHC) and looks forward to the deepening of a working relationship around matters of mutual interest and concern.

## CHRE

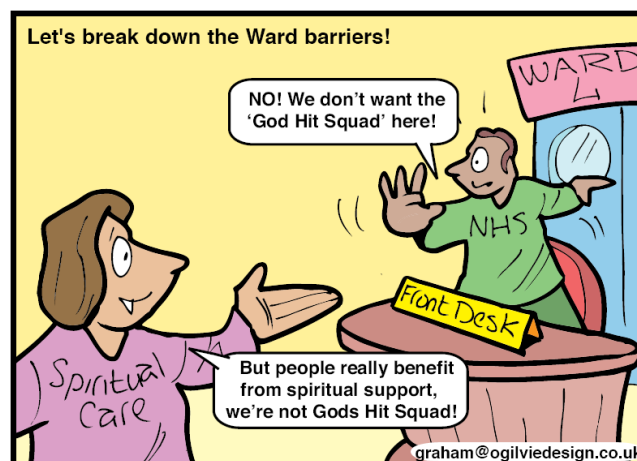

## OUR ON-GOING WORK
