#### 5. Matters Arising

NHS England Chaplaincy Guidelines are now available

Faith accreditation is through Healthcare Chaplaincy Faith and Belief Group (HCFBG) formerly MFGHC

Faith group connection is not always completed by registrants on their CPD return – registrants will be asked for clarification.

Faith group accreditation is a requirement for employment as a healthcare chaplain in as well as for registration with UKBHC

It was agreed that the term, 'in good standing', in relation to faith group accreditation should be clarified and guidance issued.

#### 6. PAS Accreditation Application

IM reported that there had been a full and thorough response from the PSA

MB had prepared an action program to take the application forward:



The risk register needs further work Action: IM and BM

Clarity to the definition of the work that H &S Cs carry out is required

Clarity on the relationship between UKBHC and professional bodies is required.

UKBHC will be applying to be a company limited by guarantee.

The meeting discussed responses to specific items on the application

3b UKBHC should survey employers to identify risks associated with HC practice.

UKBHC needs to be proactive in looking for the risks that other stakeholders may identify and use the risk register to mitigate against the risk.

BM proposed that UKBHC should focus on employers in the short term and develop a long term strategic plan.

MC suggested that contact with employers would be best coming from DH/NHS England on the back of the Guidelines.
