1. Welcome and Introduction

5. Matters Arising

5.1 DF reported on the forward progress of chaplaincy with NHS England.

Professional Chaplains Leader Forum has been established following the meeting on 5 August 2013 to discuss the relationship between NHS chaplains and NHS England:

A statement outlining the forward travel was prepared and circulated throughout the chaplaincy profession

A monthly conference of the Forum will happen and the minutes circulated.

DH will continue to fund MM's post and the work of the appointment advisors

2003 DH Guidance o Chaplaincy Provision is to be re written – DH has agreed to fund the work lead by Rev Dr Chris Swift .

Guidelines will include a consultation on the relationship of chaplains to the 2003 Data Protection Act. DF will advise.

Prof Steve Field has moved on to be the Inspector of GPs

The meeting endorsed and affirmed DF and ST to pursue and active relationship with whoever is appointed to lead on chaplaincy in NHS England.

5.3 Professional Association of Community Health Care Chaplaincy (PACHC)

PACHC have made and approach to DF to be part of UKBHC

This identifies a need for a coherent pathway for individuals towards becoming registered chaplains.

DM stated that there is a robustness to the registration process outlined on the website.

DF to write to PACHC to welcome individuals who wish to apply to be on the register.

Consideration was give to a consultation paper on the specialism.

6. On Registration and Faith Community Accreditation

DM requested time to seek guidance as to the definition of what constitutes a 'mainstream faith community.

DM requires a letter to clarify the position of UKBHC as U of G has denied a place on PG Dip Healthcare Chaplaincy to a person whose faith back ground is a Christian spiritualist. The course requirements are

to be in a placement within healthcare chaplaincy service. This requires a chaplain to be accredited by a mainstream faith community as denoted by MFGHC or Interfaith Scotland.

UKBHC position is:

Registration requires accreditation from a mainstream faith community as denoted by MFGHC and Interfaith Scotland.



The meeting discussion outlined that:

Mainstream faith communities could be defined as those with a structure of accountability.

There was uncertainty about whether it was an employment requirement to be part of a mainstream faith community.

The 2010 Equalities Act may need to be addressed for clarity.

DF to draft a letter to DM clarifying UKBHC position.

Point of contact with Roman Catholic Church is Fr. Paul Mason

7.0 Lead Officers

7.1 Professional Conduct

Fitness to Practice

DM reported that he had responded to a request for advice from a Health Board and attended a disciplinary hearing of a chaplain accused of bullying.

The following was identified by the meeting:

- A need to think through the Fitness to Practice Committee procedure and practicalities
- If A.N Other above then applied for another post, how would their registration status be affected and how would it follow them?
- What is the role of UKBHC in giving advice to Boards/Trusts?
- Is the UKBHC indemnified to act in an advisory capacity in disciplinary cases?

7.2 Professional Appointment Advisors

The Reference Group met in September and is now Chaired by Rev. Dr. Chris Swift.

There are currently 2 vacancies on the group, one of which is to held by a Roman Catholic representative.

A Training Day is planned for 17 March 2014



There are 24 advisors and 5 in training

Letters have been sent to the Trusts where advisors are employed thanking them for allowing time for the work to be carried out.

Letters have been sent to all Trusts, hospices and private organisations informing them of the role of appointment advisors.

Advisors currently work across England, Wales and NI. It is hoped that Scotland will be included soon.

MM presented a report on the activity of the advisors and made comment on the picture of the number of appointable applicants that the statistics seem paint.

7.3 Finance

DM presented a finance report for 2012/13 and a budget for 12013/14

DM made some recommendations to the Board to be discussed at AGM.

8.0 Accreditation Roadmap

MB reported that he had had a conversation with Rick Borges at PSA who asked,

- Where is UKBHC on the pathway to accreditation with PSA.
- He sited that several organisations were now registered.
- RB was in discussion with DH to seek funding to help small professional groups to meet the costs of accreditation.
- RB is willing to attend the November meeting and offered to review the documentation so far.
- It was noted that some organisations had one or more fulltime administrators

MB asked whether we had a timescale for accreditation with PSA and identified that there are a number of tasks to be done to move along IM's template for registration.

These can be answered by completing the PSA elf assessment form. The gaps are:

- Can UKBHC demonstrate sufficient funds?
- Need to ensure appropriate indemnity cover.
 - MB to explore premiums similar to Pharmacological Society of NI
- Evidence the meeting of the 37 Standards
- Explain the purpose of the register
- Ensure a favourable response from faith communities may require further ground work.



A Task group will prepare a draft Accreditation Application for Nov meeting. MB/IM/MS to meet in Belfast on 28 October.

IM will be sending out a request to all chaplaincy departments to give examples of risk to compile a risk register for Accreditation.

DM reported that much updating has already been done. It was agreed that MS should send any further updated info to webmaster as/when appropriate.
