Functions of the UKBHC

UKBHC is an organisation of practising healthcare chaplains whose primary objects are to:

- Promote the health, safety and wellbeing of patients and service users and the protection of the public, through the UKBHC Code of Conduct and the maintenance of the register of UKBHC registered health and social care chaplains.
- Advance and disseminate the knowledge and practice of healthcare chaplaincy;
- Define and develop professional standards of chaplaincy including education, training and continuing professional development;
- Train advisers to support employers in the selection and appointment of healthcare chaplains;
- Operate procedures to consider, investigate and assess the professional conduct of registered chaplains;
- Maintain and develop systems to promote and accredit continuing professional development and the professional registration of chaplains.
- Maintain a voluntary register of health and social care chaplains.

From the new Chair — Tony Brookes

UKBHC - Vision - June 23-Dec 24

This paper follows from the Board meeting held on 6th June 2023. At that meeting, the Board agreed to the appointment of a new Chair. The board asked for a short paper providing an indication of the Chair's vision and priorities. This

paper responds to that request, setting out how I believe the board should REACH out during this time, providing a broad outline of what I see as the key steps in the coming months. The routine business of the Board must continue to a high standard

1. Re-connecting Registrants

The primary purpose of UKBHC is to promote and ensure patient safety in respect of providing Chaplaincy/Pastoral and Spiritual Care in Healthcare. Therefore, it is essential that colleagues providing services day-to-day see some necessity of initial and continued registration. In this regard I would hope the focus might be on

- Delivering additional routes into registration
- Reconnecting in a meaningful way with registrants
- Connecting colleagues to develop practice
- Developing a vocational canon

2. Engaging with employers

Whilst UKBHC seeks to encourage colleagues delivering Chaplaincy/Pastoral and Spiritual Care to become registrants, it is noticeable that when making appointments, and in on-going employment, employers Trusts have had a variable regard towards the value of applicants being registered. Promoting UKBHC to employers will be essential, and in particular addressing three questions

- What does UKBHC do?
- Why does registration matter?

- What is the benefit to patients, staff and the Trust or Health Board?

This is likely to require developing contact with employers – Directors of Nursing, HR/Org Dev (suggest twice a year).

3. Articulating need

Chaplaincy/Pastoral Care colleagues and their employers sometimes question the benefit of employing UKBHC registrants or funding costs associated with registration. Some choose almost to disregard the need for either initial or maintained registration. We can learn from other professions with voluntary registers.

- Engage via registrar with other professional bodies holding voluntary registers
- Deliver appropriate changes arising from lessons learned through this engagement
- Deliver the model Job/Person specifications.
- Continue to work with NHS bodies and Hospice guidance to ensure the value of colleagues being registered is mad clear

4. Communicating regularly

Communication with registrants, employers and the wider NHS is likely to be key to achieving the ambitions outlined in this paper over the next 12 -18 months. This is likely to involve:

- Reconnecting regularly with national Chaplaincy forums
- Developing social media presence
- Developing appropriate 'meet the team' podcasts, tweets
- Delivering the ambition to develop UKBHC 'Ambassadors'
- Delivering on a commitment to upgrade UKBHC website

To support this it might be helpful to have something of a communications strategy agreed by the board updating on the work of the board and sending key messages.

5. Helping the profession mature

With NHS Chaplaincy guidelines and strategic direction being reviewed in England, Wales and Scotland there is a pressing need to complete some significant 'work in progress' including:

- Urgently decreasing the number of applications in process
- Delivering the effective roll out of new categories of registration, addressing the detail in advance of roll-out

- Prioritising an increase in associate registration in order to support all the strands of work identified earlier in this plan
- Ensuring the governance group reviews structures urgently to develop capacity to deliver these plans in order to progress the agenda and support the maturing of the profession.

Clearly, the vision must translate into actions, and the actions must ensure that Healthcare Chaplaincy continues to maintain and develop a professional framework which demonstrates value to the Public, to Employers and to Registrants.

However, delivery is the key, and delivery is entirely dependent upon the willingness and capacity of us all to do the work associated with the vision.
